THE HISTORICAL CONTEXT OF BIOLOGY IN BIBLICAL TEXTS

CREATION NARRATIVES: SCIENCE AND FAITH

THESE LAWS OUTLINE DIETARY RESTRICTIONS AND GUIDELINES FOR CLEANLINESS, REFLECTING AN EARLY UNDERSTANDING OF HYGIENE THAT RESONATES WITH MODERN BIOLOGICAL PRINCIPLES OF HEALTH AND DISEASE PREVENTION.

OLD EARTH CREATIONISM, ON THE OTHER HAND, ACCEPTS GEOLOGICAL AND ASTRONOMICAL EVIDENCE FOR AN ANCIENT EARTH WHILE MAINTAINING THAT GOD PLAYED A KEY ROLE IN THE CREATION OF LIFE.

MODERN PERSPECTIVES: BIOLOGISTS AND THEOLOGIANS
