## EUKARYOTIC CELLS

EUKARYOTIC CELLS ARE MORE COMPLEX AND LARGER, CONTAINING A NUCLEUS AND VARIOUS MEMBRANE-BOUND ORGANELLES THAT PERFORM SPECIFIC FUNCTIONS. THEY CAN BE SINGLE-CELLED OR MULTICELLULAR, WITH EXAMPLES INCLUDING PLANTS, ANIMALS, FUNGI, AND PROTISTS. IMPORTANT FEATURES INCLUDE:

- DOMINANCE: SOME ALLELES CAN MASK THE EXPRESSION OF OTHERS, LEADING TO DOMINANT AND RECESSIVE TRAITS.

## MODERN GENETICS

WITH ADVANCEMENTS IN TECHNOLOGY, MODERN GENETICS HAS EXPANDED TO INCLUDE MOLECULAR GENETICS, GENOMICS, AND BIOTECHNOLOGY. TECHNIQUES SUCH AS CRISPR ALLOW SCIENTISTS TO EDIT GENES, LEADING TO POTENTIAL SOLUTIONS FOR GENETIC DISORDERS AND ENHANCED AGRICULTURAL PRACTICES.

## EVOLUTION AND NATURAL SELECTION
