UNDERSTANDING FORENSIC SCIENCE

FORENSIC SCIENCE IS THE APPLICATION OF SCIENTIFIC PRINCIPLES AND TECHNIQUES TO INVESTIGATE CRIMES AND ANALYZE EVIDENCE. IT ENCOMPASSES VARIOUS DISCIPLINES, INCLUDING CHEMISTRY, BIOLOGY, AND PHYSICS, EACH CONTRIBUTING TO THE COMPREHENSIVE UNDERSTANDING OF CRIMINAL ACTIVITIES. - **ATTENTION TO DETAIL:** PRECISION IN OBSERVING AND DOCUMENTING EVIDENCE IS CRUCIAL FOR MAINTAINING THE INTEGRITY OF INVESTIGATIONS.
- **TECHNICAL PROFICIENCY:** FAMILIARITY WITH LABORATORY EQUIPMENT AND TECHNIQUES USED IN FORENSIC ANALYSIS.
- **COMMUNICATION SKILLS:** THE CAPABILITY TO CONVEY FINDINGS CLEARLY IN WRITTEN REPORTS AND ORAL TESTIMONIES.
- **PROBLEM-SOLVING SKILLS:** CREATIVITY AND RESOURCEFULNESS IN OVERCOMING CHALLENGES ENCOUNTERED DURING INVESTIGATIONS.

DEVELOPING THESE SKILLS IS OFTEN A FOCUS OF FORENSIC SCIENCE PROGRAMS, AS THEY DIRECTLY IMPACT A FORENSIC SCIENTIST'S EFFECTIVENESS IN THEIR ROLE WITHIN THE JUSTICE SYSTEM.

CAREER OPPORTUNITIES IN FORENSIC SCIENCE
