FUNDAMENTALS OF CELL STRUCTURE AND FUNCTION

CELL STRUCTURE AND FUNCTION FORM THE CORNERSTONE OF BIOLOGY. ALL LIVING ORGANISMS ARE COMPOSED OF CELLS, WHICH ARE THE BASIC UNITS OF LIFE. UNDERSTANDING THE DIFFERENT TYPES OF CELLS AND THEIR FUNCTIONS IS CRUCIAL FOR GRASPING MORE COMPLEX BIOLOGICAL CONCEPTS. CELLS CAN BE BROADLY CATEGORIZED INTO PROKARYOTIC AND EUKARYOTIC CELLS.

PROKARYOTIC CELLS

PROKARYOTIC CELLS ARE SIMPLE, UNICELLULAR ORGANISMS WITHOUT A NUCLEUS. THEY BELONG TO TWO MAIN DOMAINS: BACTERIA AND ARCHAEA. KEY FEATURES OF PROKARYOTIC CELLS INCLUDE:

EUKARYOTIC CELLS

EUKARYOTIC CELLS ARE MORE COMPLEX AND CAN BE UNICELLULAR OR MULTICELLULAR. THEY POSSESS A DEFINED NUCLEUS AND VARIOUS ORGANELLES THAT PERFORM SPECIFIC FUNCTIONS. EUKARYOTIC CELLS CAN BE FOUND IN ANIMALS, PLANTS, FUNGI, AND PROTISTS. IMPORTANT ORGANELLES INCLUDE:

- NUCLEUS: CONTAINS THE CELL'S GENETIC MATERIAL.
- MITOCHONDRIA: KNOWN AS THE POWERHOUSE OF THE CELL, RESPONSIBLE FOR ENERGY PRODUCTION.
- CHLOROPLASTS: FOUND IN PLANT CELLS, INVOLVED IN PHOTOSYNTHESIS.
- ENDOPLASMIC RETICULUM: A NETWORK INVOLVED IN PROTEIN AND LIPID SYNTHESIS.
- GOLGI APPARATUS: MODIFIES AND PACKAGES PROTEINS FOR SECRETION OR USE WITHIN THE CELL.

THE BASICS OF GENETICS

GENETICS IS THE STUDY OF HEREDITY AND VARIATION IN ORGANISMS. IT EXPLAINS HOW TRAITS ARE PASSED FROM ONE GENERATION TO THE NEXT THROUGH GENES, WHICH ARE SEGMENTS OF DNA. UNDERSTANDING GENETICS IS CRUCIAL FOR FIELDS SUCH AS MEDICINE, AGRICULTURE, AND BIOTECHNOLOGY.

DNA STRUCTURE AND FUNCTION
