UNDERSTANDING THE BIOLOGICAL LIMITS

BIOLOGY, AS A SCIENCE, RELIES ON UNDERSTANDING THE MECHANISMS OF LIFE, FROM THE CELLULAR LEVEL TO COMPLEX ECOSYSTEMS. HOWEVER, THERE ARE INHERENT LIMITS TO BIOLOGICAL UNDERSTANDING. THESE LIMITS CAN BE CLASSIFIED INTO SEVERAL KEY AREAS.

LIMITS OF BIOLOGICAL KNOWLEDGE

THESE QUESTIONS HIGHLIGHT THE NEED FOR CAREFUL CONSIDERATION AS WE NAVIGATE THE IMPLICATIONS OF ENHANCING HUMAN BIOLOGY THROUGH TECHNOLOGY.
