UNDERSTANDING NET CHANGE

THE IMPORTANCE OF RATE OF CHANGE

$$\text{NET CHANGE} = \int_a^b f'(t) dt$$

THIS RELATIONSHIP BETWEEN THE DERIVATIVE AND THE INTEGRAL IS FOUNDATIONAL IN CALCULUS AND IS KEY TO SOLVING NET CHANGE PROBLEMS.

FUNDAMENTAL THEOREM OF CALCULUS

THE FUNDAMENTAL THEOREM OF CALCULUS CONNECTS DIFFERENTIATION AND INTEGRATION, ESTABLISHING A POWERFUL RELATIONSHIP BETWEEN THE TWO OPERATIONS. IT CONSISTS OF TWO PARTS:

- **PART 1:** If f is continuous on the interval $[a, b]$ and F is an antiderivative of f , then:

$$\int_a^b f(x) \, dx = F(b) - F(a)$$

- **PART 2:** If f is continuous on $[a, b]$, then the function F defined by:

$$F(x) = \int_a^x f(t) \, dt$$

is continuous on $[a, b]$ and differentiable on (a, b) , with $F'(x) = f(x)$.

This theorem not only provides a method for calculating definite integrals but also reinforces the concept of net change by showing how the total accumulation of change can be calculated through integration.

COMMON TYPES OF NET CHANGE PROBLEMS

Net change problems can be categorized based on their context and the type of function involved. Here are some common types:

- **DISTANCE TRAVELED:** In problems where velocity is given, students must integrate the velocity function to find the total distance traveled over a time interval.

Each of these problems requires a clear understanding of the underlying function and the ability to apply integration appropriately.

STRATEGIES FOR SOLVING NET CHANGE PROBLEMS

EXAMPLE 1: DISTANCE TRAVELED

SUPPOSE A CAR TRAVELS WITH A VELOCITY GIVEN BY THE FUNCTION $v(t) = 3t^2$ METERS PER SECOND FROM $t = 1$ TO $t = 4$. TO FIND THE DISTANCE TRAVELED, WE SET UP THE INTEGRAL:

$$\text{DISTANCE} = \int_1^4 3t^2 \, dt$$

CALCULATING THE INTEGRAL:

$$\text{DISTANCE} = \left[t^3 \right]_1^4 = 4^3 - 1^3 = 64 - 1 = 63 \text{ METERS.}$$

EXAMPLE 2: POPULATION GROWTH

CONSIDER A SCENARIO WHERE THE RATE OF POPULATION GROWTH IS MODELED BY THE FUNCTION $P'(t) = 50e^{0.1t}$ INDIVIDUALS PER YEAR. TO FIND THE NET CHANGE IN POPULATION FROM YEAR 0 TO YEAR 5, WE INTEGRATE:

$$\text{NET CHANGE} = \int_0^5 50e^{0.1t} \, dt$$

CALCULATING THIS INTEGRAL GIVES:

$$\text{NET CHANGE} = \left[500e^{0.1t} \right]_0^5 = 500(e^{0.5} - 1) \approx 61.6 \text{ INDIVIDUALS.}$$

COMMON MISTAKES TO AVOID

STUDENTS OFTEN ENCOUNTER SPECIFIC PITFALLS WHEN TACKLING NET CHANGE PROBLEMS. BEING AWARE OF THESE CAN HELP PREVENT ERRORS:
