UNDERSTANDING LIMITS

FORMAL DEFINITION OF A LIMIT

THE FORMAL DEFINITION OF A LIMIT STATES THAT THE LIMIT OF A FUNCTION $f(x)$ AS x APPROACHES a IS L IF, FOR EVERY NUMBER $\epsilon > 0$, THERE EXISTS A NUMBER $\delta > 0$ SUCH THAT WHENEVER $0 < |x - a| < \delta$, IT FOLLOWS THAT $|f(x) - L| < \epsilon$. THIS RIGOROUS DEFINITION UNDERPINS THE CONCEPT OF CONTINUITY AND DIFFERENTIABILITY.

TECHNIQUES FOR EVALUATING LIMITS

THERE ARE SEVERAL METHODS TO EVALUATE LIMITS IN CALCULUS:

- **DIRECT SUBSTITUTION:** THE SIMPLEST METHOD, WHERE YOU SUBSTITUTE THE VALUE OF a INTO $f(x)$.
- **FACTORING:** FACTOR THE FUNCTION AND SIMPLIFY TO ELIMINATE ANY INDETERMINATE FORMS.
- **RATIONALIZATION:** USED PRIMARILY WITH SQUARE ROOTS TO ELIMINATE IRRATIONAL NUMBERS IN THE NUMERATOR OR DENOMINATOR.
- **L'HÔPITAL'S RULE** APPLIES TO LIMITS THAT RESULT IN INDETERMINATE FORMS LIKE $\frac{0}{0}$ OR $\frac{\infty}{\infty}$. IT INVOLVES TAKING THE DERIVATIVE OF THE NUMERATOR AND DENOMINATOR.

DERIVATIVES: DEFINITION AND TECHNIQUES

DERIVATIVES ARE A KEY CONCEPT IN CALCULUS, REPRESENTING THE RATE OF CHANGE OF A FUNCTION. UNDERSTANDING HOW TO CALCULATE DERIVATIVES IS CRUCIAL FOR SOLVING PROBLEMS IN AP CALCULUS. $$f'(a) = \lim_{h \rightarrow 0} \frac{f(a+h) - f(a)}{h}$$

THIS DEFINITION HIGHLIGHTS THE CONCEPT OF INSTANTANEOUS RATE OF CHANGE AND IS FUNDAMENTAL TO CALCULUS.

COMMON DERIVATIVE RULES

SEVERAL RULES CAN SIMPLIFY THE PROCESS OF FINDING DERIVATIVES:

- **POWER RULE:** IF $f(x) = x^n$, THEN $f'(x) = nx^{n-1}$.
- **PRODUCT RULE:** IF $f(x) = g(x) \cdot h(x)$, THEN $f'(x) = g'(x)h(x) + g(x)h'(x)$.
- **QUOTIENT RULE:** IF $f(x) = \frac{g(x)}{h(x)}$, THEN $f'(x) = \frac{g'(x)h(x) - g(x)h'(x)}{(h(x))^2}$.
- **CHAIN RULE:** IF $f(x) = g(h(x))$, THEN $f'(x) = g'(h(x))h'(x)$.

APPLICATIONS OF DERIVATIVES

UNDERSTANDING DERIVATIVES IS NOT ONLY ABOUT COMPUTATION; IT IS ALSO ABOUT APPLYING THESE CONCEPTS IN VARIOUS SCENARIOS. FINDING CRITICAL POINTS

CRITICAL POINTS OCCUR WHERE THE DERIVATIVE IS ZERO OR UNDEFINED. THESE POINTS ARE ESSENTIAL FOR DETERMINING THE LOCAL EXTREMA OF A FUNCTION. TO FIND CRITICAL POINTS, FOLLOW THESE STEPS:

1. COMPUTE $f'(x)$.

2. SET $f'(x) = 0$ AND SOLVE FOR x .

3. IDENTIFY WHERE $f'(x)$ IS UNDEFINED.

USING THE FIRST AND SECOND DERIVATIVE TESTS

THE FIRST DERIVATIVE TEST HELPS DETERMINE WHETHER A CRITICAL POINT IS A LOCAL MAXIMUM, LOCAL MINIMUM, OR NEITHER BY ANALYZING THE SIGN OF f' BEFORE AND AFTER THE CRITICAL POINT. THE SECOND DERIVATIVE TEST PROVIDES INFORMATION ABOUT CONCAVITY AND CAN CONFIRM WHETHER A CRITICAL POINT IS A MAXIMUM OR MINIMUM BASED ON THE SIGN OF $f''(x)$.

CONTINUITY AND DISCONTINUITY

CONTINUITY IS A CRUCIAL CONCEPT IN CALCULUS THAT ENSURES A FUNCTION BEHAVES PREDICTABLY. A FUNCTION IS CONTINUOUS AT A POINT a IF:

- THE FUNCTION $f(a)$ IS DEFINED.
- THE LIMIT $\lim_{x \rightarrow a} f(x)$ EXISTS.
- BOTH VALUES ARE EQUAL: $f(a) = \lim_{x \rightarrow a} f(x)$.

DISCONTINUITIES CAN OCCUR IN SEVERAL FORMS, INCLUDING REMOVABLE, JUMP, AND INFINITE DISCONTINUITIES. UNDERSTANDING THESE TYPES ALLOWS STUDENTS TO ANALYZE FUNCTIONS MORE EFFECTIVELY.
