SIGNIFICANCE OF THE AMERICAN CHEMISTRY COUNCIL ADDRESS

- **SUSTAINABILITY:** THE ACC CHAMPIONS SUSTAINABLE PRACTICES WITHIN THE CHEMICAL SECTOR, EMPHASIZING THE IMPORTANCE OF ENVIRONMENTAL STEWARDSHIP.
- **INNOVATION:** THE ORGANIZATION SUPPORTS RESEARCH AND DEVELOPMENT EFFORTS TO ADVANCE NEW TECHNOLOGIES AND PRODUCTS IN CHEMISTRY.
