

CAUSTIC MEANING IN CHEMISTRY

CAUSTIC SUBSTANCES ARE OFTEN EMPLOYED IN A VARIETY OF CHEMICAL REACTIONS AND PROCESSES. THEIR REACTIVITY MAKES THEM VALUABLE IN NUMEROUS APPLICATIONS, BUT IT ALSO NECESSITATES STRICT SAFETY PROTOCOLS TO PREVENT ACCIDENTS AND INJURIES. CLASSIFICATION OF CAUSTIC AGENTS

CORROSIVE ACIDS

ORGANIC CAUSTIC COMPOUNDS

COMMON EXAMPLES OF CAUSTIC SUBSTANCES

1. SODIUM HYDROXIDE

SODIUM HYDROXIDE, ALSO KNOWN AS LYE, IS A VERSATILE CAUSTIC AGENT USED IN SOAP MAKING, DRAIN CLEANING, AND FOOD

PROCESSING. ITS HIGH pH LEVEL MAKES IT EFFECTIVE IN BREAKING DOWN GREASE AND ORGANIC MATERIALS.

2. POTASSIUM HYDROXIDE

SIMILAR TO SODIUM HYDROXIDE, POTASSIUM HYDROXIDE IS UTILIZED IN VARIOUS APPLICATIONS, INCLUDING BIODIESEL PRODUCTION AND AS AN ELECTROLYTE IN ALKALINE BATTERIES. IT IS HIGHLY SOLUBLE IN WATER AND VERY CAUSTIC.

3. CALCIUM HYDROXIDE

CALCIUM HYDROXIDE, ALSO KNOWN AS SLAKED LIME, IS USED IN CONSTRUCTION, WATER TREATMENT, AND AS A FOOD ADDITIVE. IT CAN CAUSE IRRITATION AND BURNS UPON CONTACT WITH SKIN OR EYES.

4. SULFURIC ACID

SULFURIC ACID IS ONE OF THE MOST WIDELY USED INDUSTRIAL CHEMICALS. IT IS ESSENTIAL IN BATTERY MANUFACTURING, FERTILIZER PRODUCTION, AND PETROLEUM REFINING. ITS STRONG CORROSIVE NATURE NECESSITATES CAREFUL HANDLING.

5. HYDROCHLORIC ACID

THIS STRONG ACID IS USED IN VARIOUS CLEANING APPLICATIONS AND IS ESSENTIAL IN THE PRODUCTION OF CHLORIDES, FERTILIZERS, AND DYES. IT CAN CAUSE SEVERE BURNS AND RESPIRATORY ISSUES IF INHALED.

APPLICATIONS IN VARIOUS INDUSTRIES
