INTRODUCTION TO OILS AND FATS

STRUCTURE OF OILS AND FATS

THE FUNDAMENTAL BUILDING BLOCKS OF OILS AND FATS ARE FATTY ACIDS AND GLYCEROL.

FATTY ACIDS

FATTY ACIDS ARE LONG HYDROCARBON CHAINS THAT CAN BE SATURATED OR UNSATURATED.

- **SATURATED FATTY ACIDS:** THESE HAVE NO DOUBLE BONDS BETWEEN CARBON ATOMS AND ARE TYPICALLY SOLID AT ROOM TEMPERATURE. COMMON SOURCES INCLUDE ANIMAL FATS AND BUTTER.

- **UNSATURATED FATTY ACIDS:** THESE CONTAIN ONE OR MORE DOUBLE BONDS AND ARE USUALLY LIQUID AT ROOM TEMPERATURE. THEY CAN BE FURTHER CLASSIFIED INTO MONOUNSATURATED AND POLYUNSATURATED FATTY ACIDS. SOURCES INCLUDE OLIVE OIL AND FISH OIL.

THE PRESENCE OF DOUBLE BONDS IN UNSATURATED FATTY ACIDS INTRODUCES KINKS IN THE CHAIN, PREVENTING THE MOLECULES FROM PACKING CLOSELY TOGETHER, WHICH EXPLAINS THEIR LIQUID STATE.

GLYCEROL AND TRIGLYCERIDES

GLYCEROL, A THREE-CARBON ALCOHOL, COMBINES WITH THREE FATTY ACIDS TO FORM TRIGLYCERIDES, THE PRIMARY STORAGE FORM OF LIPIDS IN THE BODY AND THE MAIN COMPONENT OF DIETARY FATS. THE STRUCTURE OF TRIGLYCERIDES CAN VARY SIGNIFICANTLY DEPENDING ON THE COMBINATION OF FATTY ACIDS ATTACHED TO THE GLYCEROL BACKBONE. THIS STRUCTURAL DIVERSITY LEADS TO DIFFERENCES IN MELTING POINTS, SOLUBILITY, AND NUTRITIONAL PROPERTIES.

TYPES OF OILS AND FATS

OILS AND FATS CAN BE CATEGORIZED BASED ON THEIR ORIGIN, COMPOSITION, AND USAGE.

PLANT-BASED VS. ANIMAL-BASED FATS

- **PLANT-BASED FATS:** EXAMPLES INCLUDE OLIVE OIL, COCONUT OIL, AND CANOLA OIL. THESE FATS ARE GENERALLY HIGHER IN UNSATURATED FATTY ACIDS AND LOWER IN SATURATED FATTY ACIDS.

EXTRACTION AND REFINEMENT PROCESSES

EXTRACTION METHODS

- **DEGUMMING:** REMOVING PHOSPHOLIPIDS AND IMPURITIES.
- **NEUTRALIZATION:** ELIMINATING FREE FATTY ACIDS.
- **BLEACHING:** REMOVING COLOR PIGMENTS.
- **DEODORIZATION:** ELIMINATING VOLATILE COMPOUNDS THAT CAUSE ODORS.

THESE PROCESSES ENHANCE THE OIL'S STABILITY, FLAVOR, AND SHELF LIFE.

APPLICATIONS OF OILS AND FATS

OILS AND FATS HAVE DIVERSE APPLICATIONS ACROSS VARIOUS SECTORS.

CULINARY USES

IN COOKING, OILS AND FATS ARE ESSENTIAL FOR:

- **FLAVOR ENHANCEMENT:** MANY DISHES RELY ON FATS TO CARRY FLAVORS.

A: ESSENTIAL FATTY ACIDS ARE TYPES OF POLYUNSATURATED FATS THAT THE BODY CANNOT SYNTHESIZE AND MUST BE OBTAINED FROM THE DIET. THEY INCLUDE OMEGA-3 AND OMEGA-6 FATTY ACIDS, CRUCIAL FOR VARIOUS BODILY FUNCTIONS.

Q: HOW DO OILS AND FATS CONTRIBUTE TO FOOD PRESERVATION?
