UNDERSTANDING CHEMISTRY SAFETY RULES

- **FACE SHIELDS:** FACE SHIELDS PROVIDE ADDITIONAL PROTECTION FOR THE FACE AND NECK AGAINST SPLASHES.

IT IS ESSENTIAL FOR LABORATORY PERSONNEL TO SELECT THE APPROPRIATE TYPE OF PPE BASED ON THE SPECIFIC CHEMICALS THEY ARE WORKING WITH. REGULAR INSPECTION AND MAINTENANCE OF PPE ARE ALSO NECESSARY TO ENSURE ITS EFFECTIVENESS.

CHEMICAL STORAGE AND LABELING

- **HAZARD SYMBOLS:** RELEVANT HAZARD SYMBOLS INDICATING THE NATURE OF THE CHEMICAL.
- **CONCENTRATION:** THE CONCENTRATION OF THE CHEMICAL IN THE CONTAINER.
- **STORAGE INSTRUCTIONS:** SPECIFIC INSTRUCTIONS FOR SAFE HANDLING AND STORAGE.

CHEMICAL DISPOSAL PROCEDURES
