UNDERSTANDING CHEMISTRY SAFETY SYMBOLS

CATEGORIES OF CHEMISTRY SAFETY SYMBOLS

THIS STANDARDIZATION HELPS IMPROVE COMMUNICATION ABOUT CHEMICAL HAZARDS ACROSS DIFFERENT REGIONS AND INDUSTRIES.

COMMON CHEMISTRY SAFETY SYMBOLS

THE EXCLAMATION MARK INDICATES THAT A SUBSTANCE MAY CAUSE IRRITATION, SENSITIZATION, OR OTHER HEALTH EFFECTS. THIS SYMBOL IS OFTEN ASSOCIATED WITH CHEMICALS THAT CAN CAUSE SKIN OR EYE IRRITATION.

4. CORROSION SYMBOL

THIS SYMBOL IS USED FOR CORROSIVE SUBSTANCES THAT CAN DAMAGE METALS, SKIN, AND OTHER MATERIALS UPON CONTACT. IT IS ESSENTIAL TO USE PROTECTIVE EQUIPMENT WHEN HANDLING THESE CHEMICALS.

5. ENVIRONMENT SYMBOL

BEST PRACTICES FOR CHEMICAL SAFETY

TO ENSURE SAFETY WHEN WORKING WITH CHEMICALS, IT IS ESSENTIAL TO FOLLOW BEST PRACTICES THAT MINIMIZE THE RISK OF
