PROPERTIES OF FLAMMABLE SUBSTANCES

THE PROPERTIES OF FLAMMABLE SUBSTANCES ARE CRITICAL IN DETERMINING THEIR BEHAVIOR UNDER VARIOUS CONDITIONS. SEVERAL KEY CHARACTERISTICS ARE COMMONLY EVALUATED:

FLASH POINT

AUTOIGNITION TEMPERATURE

THE AUTOIGNITION TEMPERATURE IS THE LOWEST TEMPERATURE AT WHICH A SUBSTANCE WILL SPONTANEOUSLY IGNITE WITHOUT AN EXTERNAL IGNITION SOURCE. THIS PROPERTY IS CRUCIAL FOR ASSESSING FIRE RISKS IN STORAGE AND HANDLING ENVIRONMENTS.

FLAMMABILITY LIMITS

FLAMMABILITY LIMITS REFER TO THE CONCENTRATION RANGE OF VAPOR IN AIR THAT CAN IGNITE. IF THE CONCENTRATION OF A FLAMMABLE VAPOR IS TOO LOW OR TOO HIGH, IT WILL NOT IGNITE. UNDERSTANDING THESE LIMITS IS VITAL FOR SAFE HANDLING AND STORAGE PRACTICES.
