TYPES OF GOGGLES USED IN CHEMISTRY

KEY FEATURES OF PROTECTIVE GOGGLES

CONSULT SAFETY GUIDELINES

ALWAYS REFER TO YOUR ORGANIZATION'S SAFETY GUIDELINES AND MATERIAL SAFETY DATA SHEETS (MSDS) FOR RECOMMENDATIONS ON APPROPRIATE EYE PROTECTION FOR SPECIFIC CHEMICALS AND PROCESSES.
