

HENRY'S LAW DEFINITION CHEMISTRY

WHAT IS HENRY'S LAW?

HENRY'S LAW STATES THAT AT A CONSTANT TEMPERATURE, THE AMOUNT OF DISSOLVED GAS IN A LIQUID IS DIRECTLY PROPORTIONAL TO THE PARTIAL PRESSURE OF THAT GAS IN EQUILIBRIUM WITH THAT LIQUID. THIS LAW WAS FORMULATED BY THE CHEMIST WILLIAM HENRY IN 1803 AND IS EXPRESSED MATHEMATICALLY AS:

$$C = k_H P$$

WHERE:

- C = CONCENTRATION OF THE DISSOLVED GAS (MOL/L)
- k_H = HENRY'S LAW CONSTANT (MOL/(L·ATM))
- P = PARTIAL PRESSURE OF THE GAS (ATM)

THIS DEFINITION HIGHLIGHTS THE DIRECT CORRELATION BETWEEN GAS SOLUBILITY AND ITS PARTIAL PRESSURE, EMPHASIZING THAT HIGHER PRESSURE LEADS TO GREATER SOLUBILITY OF THE GAS IN THE LIQUID. IF THEY ASCEND TOO QUICKLY, THE SUDDEN DROP IN PRESSURE CAN LEAD TO DECOMPRESSION SICKNESS, OR "THE BENDS," AS NITROGEN BUBBLES FORM IN THE BLOODSTREAM. THIS SITUATION ILLUSTRATES THE CRITICAL IMPORTANCE OF HENRY'S LAW IN DIVER SAFETY.

ENVIRONMENTAL MONITORING
