OTHER COMPONENTS

IN ADDITION TO HYDROCARBONS, CRUDE OIL CONTAINS:

- **SULFUR:** AN ELEMENT THAT CAN BE A CONTAMINANT AND AFFECTS THE QUALITY OF OIL.

REFINING PROCESSES

FOLLOWING DISTILLATION, CONVERSION PROCESSES TRANSFORM HEAVIER FRACTIONS INTO MORE VALUABLE PRODUCTS. KEY CONVERSION METHODS INCLUDE:

- **CRACKING:** BREAKING LARGE HYDROCARBON MOLECULES INTO SMALLER, MORE USEFUL ONES, OFTEN THROUGH THERMAL OR CATALYTIC PROCESSES.
- **REFORMING:** REARRANGING MOLECULAR STRUCTURES TO IMPROVE OCTANE RATINGS IN GASOLINE.
