UNDERSTANDING STRIPPING CHEMISTRY

CHEMICAL STRIPPING

CHEMICAL STRIPPING UTILIZES SOLVENTS AND CHEMICALS TO DISSOLVE OR BREAK DOWN THE MATERIAL THAT NEEDS TO BE REMOVED. COMMON CHEMICAL AGENTS INCLUDE:

- SOLVENT-BASED STRIPPERS (E.G., METHYLENE CHLORIDE)
- CAUSTIC SODA SOLUTIONS
- BIOCHEMICAL STRIPPERS (E.G., THOSE BASED ON ENZYMES OR BACTERIA)

CHEMICAL STRIPPING CAN BE PARTICULARLY EFFECTIVE FOR INTRICATE DESIGNS AND DELICATE SURFACES WHERE MECHANICAL METHODS MAY CAUSE DAMAGE. HOWEVER, THE CHOICE OF CHEMICAL AGENT IS CRITICAL, AS SOME MAY POSE HEALTH AND ENVIRONMENTAL RISKS.

THERMAL STRIPPING

THERMAL STRIPPING INVOLVES THE APPLICATION OF HEAT TO SOFTEN OR BURN OFF COATINGS. THIS METHOD IS COMMONLY USED FOR PAINT REMOVAL AND CAN BE ACHIEVED THROUGH:

- HEAT GUNS
- OVEN HEATING (FOR SMALLER PARTS)
- INFRARED STRIPPING SYSTEMS

THERMAL METHODS CAN BE EFFICIENT BUT MAY REQUIRE CAREFUL CONTROL OF TEMPERATURE TO PREVENT DAMAGE TO THE SUBSTRATE OR THE RELEASE OF HARMFUL FUMES.

CHEMICAL AGENTS USED IN STRIPPING

SOLVENT-BASED STRIPPERS

SOLVENT-BASED STRIPPERS ARE AMONG THE MOST WIDELY USED IN THE INDUSTRY. THEY TYPICALLY CONTAIN STRONG SOLVENTS LIKE METHYLENE CHLORIDE OR ACETONE, WHICH CAN DISSOLVE A WIDE RANGE OF COATINGS AND PAINTS. WHILE EFFECTIVE, THESE AGENTS CAN POSE SERIOUS HEALTH RISKS AND MUST BE HANDLED WITH CARE.

CAUSTIC SOLUTIONS

ALKALINE STRIPPERS, SUCH AS CAUSTIC SODA, ARE EFFECTIVE FOR REMOVING ORGANIC MATERIALS. THEY WORK BY SAPONIFICATION, A CHEMICAL REACTION THAT BREAKS DOWN FATS AND OILS, MAKING THEM EASIER TO WASH AWAY. HOWEVER, THEY REQUIRE CAREFUL HANDLING DUE TO THEIR CORROSIVE NATURE.

BIOCHEMICAL STRIPPERS

IN RECENT YEARS, THERE HAS BEEN A SHIFT TOWARDS MORE ENVIRONMENTALLY FRIENDLY SOLUTIONS, INCLUDING BIOCHEMICAL STRIPPERS. THESE PRODUCTS USE NATURAL ENZYMES OR BACTERIA TO BREAK DOWN COATINGS AND CONTAMINANTS, OFFERING A SAFER ALTERNATIVE TO TRADITIONAL CHEMICAL AGENTS.

SAFETY AND ENVIRONMENTAL CONSIDERATIONS
