ITS UNIQUE MOLECULAR STRUCTURE, WITH ONE OXYGEN ATOM BONDED TO TWO HYDROGEN ATOMS, LEADS TO A POLAR MOLECULE WITH A BENT SHAPE. THIS POLARITY PLAYS A SIGNIFICANT ROLE IN WATER'S SOLVENT CAPABILITIES.

WHY WATER IS CONSIDERED A UNIVERSAL SOLVENT
