UNDERSTANDING THE BASICS OF ASSAYS

AN ASSAY IS ESSENTIALLY A QUANTITATIVE OR QUALITATIVE ANALYSIS THAT HELPS CHEMISTS AND RESEARCHERS DETERMINE THE CHARACTERISTICS OF A SUBSTANCE. THE TERM "ASSAY" ORIGINATES FROM THE FRENCH WORD "ESSAYER," MEANING "TO TRY" OR "TO TEST." ASSAYS CAN BE PERFORMED ON VARIOUS MATERIALS, INCLUDING SOLIDS, LIQUIDS, AND GASES. THE CHOICE OF ASSAY DEPENDS ON THE SPECIFIC REQUIREMENTS OF THE ANALYSIS, SUCH AS THE TYPE OF SUBSTANCE BEING TESTED AND THE DESIRED ACCURACY OF THE RESULTS. EACH TYPE OF ASSAY HAS ITS ADVANTAGES AND LIMITATIONS, MAKING IT ESSENTIAL TO CHOOSE THE RIGHT METHOD BASED ON THE CONTEXT OF THE ANALYSIS.

COMMON METHODS USED IN ASSAYS

EACH METHOD HAS ITS SPECIFIC APPLICATIONS AND IS CHOSEN BASED ON FACTORS SUCH AS THE REQUIRED SENSITIVITY, THE NATURE OF THE SAMPLE, AND THE AVAILABLE TECHNOLOGY.
