- GASOLINE
- ETHANOL
- PROPANE
- ACETONE

NON-FLAMMABLE MATERIALS

NON-FLAMMABLE MATERIALS, ON THE OTHER HAND, DO NOT IGNITE EASILY AND REQUIRE HIGHER TEMPERATURES TO BURN. THESE MATERIALS ARE OFTEN USED IN CONSTRUCTION AND MANUFACTURING TO ENHANCE FIRE SAFETY. EXAMPLES INCLUDE:

- CONCRETE
- BRICK
- STEEL
- GLASS

TYPES OF COMBUSTIBILITY

COMBUSTIBILITY CAN BE FURTHER CATEGORIZED BASED ON THE STATE OF MATTER AND THE NATURE OF THE COMBUSTION PROCESS.

SOLID COMBUSTIBILITY

GAS COMBUSTIBILITY

GAS COMBUSTIBILITY INVOLVES GASEOUS SUBSTANCES THAT CAN IGNITE AND BURN IN THE PRESENCE OF OXYGEN. NATURAL GAS AND PROPANE ARE PRIME EXAMPLES, OFTEN USED FOR HEATING AND COOKING. GASES GENERALLY HAVE LOWER IGNITION TEMPERATURES COMPARED TO SOLIDS AND LIQUIDS.

FACTORS AFFECTING COMBUSTIBILITY

SEVERAL FACTORS INFLUENCE A MATERIAL'S COMBUSTIBILITY. UNDERSTANDING THESE FACTORS IS ESSENTIAL FOR PREDICTING FIRE BEHAVIOR AND ASSESSING RISKS.

COMPOSITION OF THE MATERIAL
